**Comprehensive Eye Exam**  
Schedule patient back for special testing day to complete AdaptDx Pro®

**Standard pre-exam testing and comprehensive eye exam**



 **Special Testing Day**  
Conduct AdaptDx Pro test to determine Rod Intercept® (RI®)  
Review test results with patient



**RI < 6.5**  
No additional treatment required for AMD  
Repeat imaging & AdaptDx Pro Rapid Test annually

**RI ≥ 6.5**  
Schedule medical office visit to evaluate for advanced AMD  
Utilize imaging technology & AdaptDx Pro Extended Test

	Subclinical AMD	Early AMD	Intermediate AMD	Advanced AMD
<b>Functional Testing (Average Rod Intercept<sup>1</sup>)</b>	<b>RI <math>\geq</math> 6.5</b> The diagnostic specificity and sensitivity of the 6.5 minute cut-point for the presence of AMD is greater than 90%	<b>12.9</b> (+/- 6.1)	<b>16.6</b> (+/- 5.2)	<b>19.0</b> (+/- 4.5)
<p>Dark adaptation speed is correlated with disease severity. The AdaptDx Pro Extended Test is a useful aid for staging AMD severity based on these average RI times.</p>
